Program Eligibility

LADOS Division 2 operates under the authority of IC § 12-23-14 and is state certified as a court administered program to provide client services including; assessment, education, case management supervision and referrals by the Indiana Office of Court Services. Our program accepts referrals from all courts in Lake County, prosecutor's pre-trial diversion program, and transfers from other courts as appropriate. Clients must be in agreement to comply with LADOS program admission, rules of conduct and fee requirements as outlined in the Orientation booklet and the accompanying Client Service Agreement.

Program Services

Our program offers strategic program services in support of our goals to effectively intervene with criminal behavior and substance abuse, including:

Orientation to explain clients' rights, and responsibilities; goals for each service offered, and LADOS Division 2 program services.

Assessment to identify problematic issues and substance use patterns to determine the appropriate level of intervention.

Substance Abuse Education to provide evidence based intervention courses emphasizing the prevention of further substance-use-related problems.

Referral to treatment for those clients who through assessment, are found to be in need of substance abuse treatment or other services. The Indiana Division of Mental Health and Addictions or other equivalent agency certifies all treatment providers utilized by the program.

Case Management to facilitate coordinated services designed to support educational and treatment goals, supervise and report compliance to criminal justice agencies mandating client to program, and care coordination to ensure quality services in addressing substance use issues and needs.



Assessment Requirements

In compliance with program certification admission standards of the Indiana Office of Court Services, all LADOS clients must complete a substance abuse assessment conducted by a LADOS Division 2 state certified Substance Abuse Case Management Specialist (CSAMS) credentialed professional. The assessment is either an in-person or tele-health interview (as approved by IOCS) to determine education and/or treatment referral requirements, and may include alcohol and drug screens. Referral provider direct service costs; which may include education and/or treatment remain the client's financial responsibility, and are to be paid directly to the referral provider. LADOS will supervise compliance until successful completion.

LADOS Division 2

Provides state certified evidence based

Substance abuse education to address substance impaired driving, and reduce recidivism.

LEVEL 2 - 10 Hour Basic Substance Abuse Education

Substance Abuse Education intervention for low to moderate risk offenders on disease concept of chemical dependency with focus on low risk lifestyle choices and behavioral adjustments.

LEVEL 3 - 20 Hour Advanced Substance Abuse Education

Comprehensive Substance Abuse Education intervention designed primarily for high risk substance abusers with symptoms indicating a progression toward dependence.
