We have discussed the issues with these offers in the past however, I am asking that you take final action for approval of one of the two offers that we received. Legal ads were placed in the newspaper advertising the parcel, along with a sign being placed on the property. No offers other than the two you are aware of have been received.

Both offers to purchase were made by one very reputable company as well as one very reputable individual. I know that the Board of Commissioners appreciates the offers made by each potential buyer and acknowledges that both offers were substantial and will serve to be a benefit to the taxpayers of Lake County. However, based upon the "Comparison of Offers" that I am attaching to this correspondence, I am recommending the Offer to Purchase submitted by Paul G.
