Comes now, member of the public, to speak before the Board of Commissioners, with public comment, Mr. Darren Washington, Member of the Calumet Township Board of Trustees, "present as a taxpayer today with concerns regarding the one hundred eighty-five thousand dollar settlement that was reached for our Lake County Recorder, first stating it is very unfair that the County Commissioners had to be involved in even reaching a settlement so by all means I want to publicly let the public know, do not blame our Commissioners because if the situation wouldn't have happened in the Recorder's Office the Commissioners and their Legal Staff wouldn't have to come to a settlement, so again, you should never have had to come to the situation, I come today with some possible solutions, first solution is that your legal counsel maybe set up a committee to look at getting a lobbyist to look at legislation that when it comes to issues in an office of romance and sex issues one hundred eighty-five thousand dollars is extremely too much money for taxpayers to have to foot the bill when we're looking at cutting budgets, when we're looking at trying to hire, trying to get people rate increases and in this situation Commissioners it just seems there's no remorse by Lake County Commissioner, inter-office affairs that produce taxpayers dollars at taxpayers expense in the County's budget is unacceptable, so the first thing, create some kind of committee within County Government to look at legislation that will at least exonerate or shift some of that responsibility, because I'm going to be honest with you today, the Lake County Recorder should be responsible for paying back some of that money, far as that settlement is concerned, and I think it is extremely unfair when you have a civil lawsuit that has extremely lower version than a criminal lawsuit that we could be on the hook possibly for even much more money if bring in civil rights and these like that, so I believe you all did the right thing in trying to cut the cost because the public doesn't know if you would've went to court with this you probably would've almost been paying seven hundred and fifty to a million dollars in total, the next thing, our Lake County Recorder very seldom is at work, we need to give our new human resources director some meet, and this is what I mean, when you have an executive like the Lake County Recorder, Auditor or Assessor, when they are elected by the people there's very few things that can be done from a human resources perspective to make sure that a person is not operating with chronic absenteeism because they're protected by the people there should be some type of legislation passed through Indianapolis to give Human Resources Directors an opportunity when there is consistent absenteeism but they have an opportunity to be able to provide penalties, the best thing that could be done is maybe looking at recall legislation for a county executive elected official, I think it's extremely unfair to put it on the voters to have to wait four years or three years to vote somebody out of office or don't elect them again when there is immediate mismanagement and costing us tax dollars, and the last thing, we work hard as residents we pay in to the Lake County Income Option Tax we pay into our property taxes, we need to look at certain mechanisms that can hold our elected officials accountable when it comes to these type of civil lawsuits, criminal lawsuits are totally different but civil lawsuits, that's the issue that I think that we are setting a dangerous precedent that if people come to work and they office romances sex for play things like that I think it's a very dangerous precedent from this standard, from this point forward, if we as a legislative body don't look at trying to implement some checks and balances to pursue, to prevent the County of having to bare the cost of civil lawsuits when it comes to things that has nothing to do with office dialogue and their work responsibilities so again you can't tell people how to operate, but imma' tell you this, when you come to work the love the sex the rumors need to be left at home or wherever you leave, but when you come into that office, you have a responsibility with your paycheck to do the job that you have been afforded to from eight o'clock to four-thiry/five o'clock, or however long you work. That's just my concern, I wanted to provide some solutions and just to let you all know as a taxpayer, I'm not the only one that feels this way, a lot of people feel this way, but people pretty much stay quiet and don't say anything, why, because Commissioners, they believe nothing will ever change, they believe that its falling on deaf ears and this kind of activity will continue to exist and so you shouldn't have to be burdened with looking at having to settle lawsuits because of certain elected

officials being irresponsible in their personal lives. Thank you, have a nice day."
