- Please enclose a cover letter that explains your request, along with identifying the owner, developer, engineer, 2. agent and the signed/notarized Power of Attorney (if required), detailed engineering plans (digital preferred or reduced copies no longer than 11 x 17), and a vicinity map with each application, which are in compliance with The Lake County Stormwater Ordinance No. 1365C (available in the Lake County Surveyor's Office and online at:
 - https://www.lakecountyin.org/departments/surveyor/ms4-stormwater-quality-c/ordinances-manuals-and-forms/
- 3. Upon receipt of application and the materials requested in Item No. 2 above, the Lake County Drainage Board will determine the fees due to process said application per Ordinance No. 1365C. Once payment has been received and the fee schedule acknowledged and agreed upon by applicant, the application will be assigned an application number and placed on the next scheduled Lake County Drainage Board Meeting for review and recommendation of the application request. Following the Board Meeting, a "Notice of Action" will be forwarded to applicant acknowledging the Board's decision. [Note: All applications received will be placed on the Drainage Board's Monthly Meeting Agenda; however, approved applications will not be released until payment of fees, set by the Lake County Drainage Board, is received.]

APPLICATION FOR WAIVER OF EASEMENT

(EASEMENT REDUCTION)

The Ditch or Creek which traverses through Section,
Township, Range, west of the 2 nd P.M
and/or, as marked and laid down on the recorded plat as the same appears
of record in Plat Book Page in the Recorder's Office of Lake County, Indiana, is a
regulated drain under the terms of the Indiana Drainage Code of 1965 as amended, and as such is subject
to a maintenance easement parallel to the drain and extending either 75 feet from the top of each bank of
an open drain or 75 feet, from the centerline on each side of a tiled drain. In consideration for the reduction
of this easement by the Lake County Surveyor/Lake County Drainage Board to feet from the top of
the bank on the side of the open drain or to feet from the centerline of the side
of the tiled drain as established per drawings of, Indiana Registered Land
Surveyor Number, dated this day of, 20, as per plat of
survey which is attached hereto and made a part hereof, and labeled Exhibit "A", the undersigned hereby
covenant that any damage occasioned by maintenance or reconstruction of the regulated drain to
structures, yards, shrubbery, improvements, fences, outbuildings and the like, whether within or without
the reduced easement, shall be at the risk of Petitioners, their successors and assigns and not the Lake
County Drainage Board, its successors, assigns, agents or employees. This covenant shall not affect
damage occurring beyond the 75-foot statutory easement. In the event that the reduced easement is not
sufficient for any spoil occasioned by maintenance of reconstruction of the ditch, the same shall be
removed in the most economical way possible and any resulting additional costs shall be the responsibility
of the Petitioners.

In the event that construction, maintenance or repair of the improvements as set forth in Exhibit "A" causes or shall cause in the future any damage to the established regulated drain or necessitates

increased maintenance thereof, Petitioner, its successors or assigns will reimburse the Lake County Drainage Board for any such expenses incurred.

In addition, the Lake County Drainage Board may exercise an option that would require the owner of the land, occupied by a regulated drain, to perform maintenance on the drain in perpetuity. The option, if exercised, shall be a covenant on, and run with the property—see attached "Perpetual Agreement". Further, it shall be signed, sealed, notarized and recorded in the Lake County Recorder's Office with a copy of said recording furnished to the Lake County Surveyor's Office for its permanent record.
